The revised Statement of Organization of Political Committee reflects changes in the composition of the committee's supporting officers. The committee's Chairman, treasurer, and registered agent remain unchanged.

The committee may be required to register with the Internal Revenue Service. For more information regarding registration requirements with the Internal Revenue Service, you must contact the Internal Revenue Service by email at [www.irs.gov/polorgs](http://www.irs.gov/polorgs) or call the IRS Tax Exempt Customer Account Service at 1-877-829-5500.

The Lee County Supervisor of Elections cannot determine whether a committee will be required to register with the Internal Revenue Service. It is important that the committee contact the Internal Revenue Service to verify whether the committee is exempt from any or all Internal Revenue Service registration requirements for political committees.
